## A1. legal status summary

**EDR** was officially registered as a non-governmental organization (NGO) according to the Sudanese Voluntary Work Act in Khartoum by HAC (Humanitarian Assistance Commission) in the year 2021. This registration is renewed annually as per prescribed procedures. According to the law, EDR has an approved constitution, article of association, and internal finance and procurement rules. Its organizational set up is formed by the Board of Directors as a supreme authority and the executive body that implements plans according to the mandate and availed resources within the specified geographical area of operations.

## **A2.EDR Background and Rationale:**

Eli-koro for Development and Reconstruction (EDR) is a Sudanese NGO registered as a national voluntary charitable humanitarian non-governmental organization founded by Sudanese youth and women volunteers, who work in humanitarian and development domain. The creation of this organization is inspired by a feeling among this group that something must be done to mitigate the sufferings of needy communities by time of the eruption of the crisis in 2003. EDR was established in 2021, and it was officially registered with the humanitarian aid commission (HAC) as a local non-governmental organization that provide relief, development assistance and to advocate and promotion human rights principles.

EDR is a non-religious, non-political and non-profit –making organization, whose vision is to promote "Peace, Unity Development, women rights and Community Empowerment across the country. EDR has been able to gaining sufficient community's confidence that would enable it to

smoothly implement its future project and program activities. In addition to that, the organization has competent, and experienced staff with a goodwill in Some States and well-equipped coordination office in Port Sudan. Accordingly, the present geographical area of operations for the organization in Sudan includes, El Fasher , El Geneina


